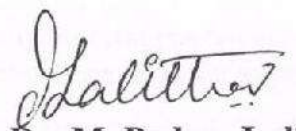

After deliberations and discussions at length and resolved in the Board of Studies (BOS) meeting. The resolutions are appended in Annexure-I.

Item No 17.4: Discussion on the R23 II, III, and IV year course structure, with a detailed discussion on the II-year syllabus.

- The chairman presented briefly, the allotment of credits to Basic Science & Humanities Courses, Engineering Science Courses, Professional Core, Professional Electives, Open Electives, Domain Specific Skill Enhancement courses, Internship & Project work & Mandatory Courses for total credits of 160. The approved course categories are appended in Annexure – II.
- The chairman presented the R23 B.Tech. Mechanical Engineering program II, III and IV Year course structure and reviewed for credits distribution in each semester for a total of 160 credits. The approved course structure is appended in Annexure – III.
- The chairman presented the list of New Courses which are about to incorporate in the R23 B.Tech. Mechanical Engineering program from II B.Tech. – I Semester to IV B.Tech. – II Semester for approval. On discussions and suggestions from experts the new courses are approved to incorporate in the R23 B.Tech. Mechanical Engineering program. The list is appended in Annexure – IV.
- The proposed syllabi of all subjects of II B.Tech. – I Semester and II B.Tech. – II Semesters along with Lecture – Tutorial – Practical's (L-T-P), Course outcomes mapping with Blooms Taxonomy and with Programme Outcomes are presented and received suggestions as following from BOS experts which are noted and will be incorporated in the syllabi.
 - Course 'Mechanics of Solids' from II B.Tech. – I Semester needed to revise the contents from Unit 3 and Unit 4 for elementary treatment of problems.
 - Course 'Material Science and Metallurgy' from II B.Tech. – I Semester need to revise with the contents of Unit 3 to be merged with Unit 4 and split units 1 into two units.
 - Course 'Computer aided Machine Drawing Lab' need to revise with the kind of 2D and 3D software's should be used which should not be repeated in the upcoming CAD lab courses.

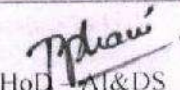

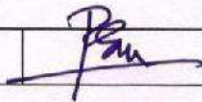

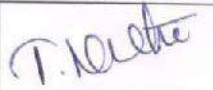
