Minutes of the Finance Committee meeting held at 11.00 am on 27.05.2019 at the institute premises.

At the outset, the Honorary Secretary extended a warm welcome to the members of the Finance Committee. He stated as follows:-

The NAAC has graded our institution with a score of 3.03 (CGPA). This alone is not sufficient for us to sustain in today's competitive environment. We have to get higher rankings in the NIRF-2020 and our B.Tech Programmes need to be accredited by NBA. We are now in the process of getting NBA accreditation for three UG Programmes. This is one step by which we are trying to improve the credibility of our courses we offer. The NBA committee is likely to visit our campus in 2020-21 academic year for assessment. At the movement, we required more improvement in the infrastructure and faculty which will qualify us for better grade in accreditation. We are getting our income through fees only. This is the major problem faced by the institute today. The resource which has to be generated from the consultancy and research is limited. Our institute is 21 year old, we have achieved many in the short span of time, but we have to go a long way and great challenges are ahead. We can have tie ups with the industries which can really contribute and fund us. The faculty members should be encouraged to have active industry relationships. At the end, Hon' Secretary appreciated the efforts taken by the finance team for changes made in the taxation system in the complexity of filling the returns etc.

The committee suggested that the budget for the year 2019-20 need to be revised and circulated to all concerned. The committee suggests considering the following during the preparation of the revised budget:

- 1. Placement and training expenditure to be increased from Rs. 41 to Rs. 60 lakhs
- 2. Institutional level Scholarships, Prizes and Awards, events to be increased from 4.24 to 10 lakhs
- 3. Additional budget for the NBA accreditation and infrastructure etc. to be included
- 4. Alumni support to be mentioned as a separate head irrespective of the income
- 5. Suggested to make separate heads for events such as workshops, seminars. conference etc, department wise
