3. Regarding readmission of students into a year or semester of study, it is resolved as given below:

• A student who has satisfied the minimum attendance requirement in any semester may repeat that semester, after obtaining written permission from the Principal and cancelling the previous record of attendance and academic performance (viz; internal evaluation and external examination marks) of the semester or year. This facility may be availed by any student at the maximum twice for a 4 year B.Tech., and only once by Lateral Entry student & PG Student during the entire course of study.
