# Item No 1: Confirmation of the minutes of the 13th Finance Committee meeting held on 27.05.2019

#### Item No 2: Action taken report on the 13th Finance committee meeting held on 27.05.2019

The Finance Committee expressed its satisfaction on the actions taken and RESOLVED to accept the Action Taken Report (ATR) on the decisions taken by it in its 13<sup>th</sup> Meeting held on 27.05.2019.

### Item No 3: Approval of Annual Accounts together with Audited Reports for the FY 2018-19 & 2019-20

Finance Committee took note of the audited financial statement for the year 2018-19 and 2019-20

#### Item No 4: To consider and approve Budget estimates for the financial year 2020-21

Budget estimates for the financial year 2020-21 was prepared and submitted to the Finance Committee. The budget prepared was accepted by the committee members. The detailed approved budget is given in Annexure-1.

#### Item No 5: To review the budget proposal for the year 2020-21

The chairman presented the budget estimates and sanctioned budget for 2020-21 before the Finance Committee.

The committee was informed that sanctioned budget as per the projected expenditure in the revised estimates for 2020-21 is of Rs 2611.52 lakhs which includes Rs. 2250 lakhs under salaries and other operational charges as against the budget estimate of Rs.2924.00 lakhs for the financial year 2020-21.

After detailed deliberations, the Finance Committee recommended the revised estimates for the year 2020-21 to the tune of Rs. 2611.52 lakhs be placed before the Governing Body for Approval.

## Point No: 6 Allocation of funds for Research and Development cell, Library, Placement cell and other functional units

The committee has approved the budget for research and development, Library, Placement cell, Departments and other Functional units is listed in Annexure-2.

#### Item No 7: Funds allocation to construct an Administrative Block

The Governing body in its previous meetings decided to go for Deemed to be University or Private University in coming years. Hence it is decided to construct an Administrative Block with 1500 square meters building with all required amenities. Hence, finance committee recommend to allocate 1 crore as primary amount to construct Administrative and it is listed in Annexure-2.

#### Item No 8: Provide funds for install more CCTVs in all buildings

The committee has approved the Budget for installing more CCTVs in and around the campus and it is listed in Annexure-2.

Item No 9: To Review the Tuition Fee fixed by APHER&MC

UG programme Fee reduced up to 20%, PG Programme Fee reduced up to 41% and PG- MCA & MBA Programmes Fee reduced up to 46%.

The chairman present that the tuition Fee is the only income source for the Institute and if such fee is reduced, the budget required to maintain quality and standards goes down and quality costs are to be reduced. For continuation of all the activities and maintaining the quality and standards of the Institute, the present tuition fee may not be sufficient. It is placed before the Governing Body for furthers discussion and approval.
