15.1: Confirmation of the minutes of the 14th Finance Committee meeting held on 15.03.2021

15.3: Approval of Annual Accounts together with Audited Reports for the FY 2020-21

It is brought to the notice of Finance committee that the Annual accounts audit is not completed owing to pandemic and several lockdowns. It can be present in the next meeting.

15.4: To consider and approve Budget estimates for the financial year 2021-22

The finance committee considered the budget utilization in the current financial year and went through the budget proposals submitted by various departments and functional units in the institute thoroughly and recommended it to the Governing Body for further approval as given in Annexure-1.

15.5: Any other item with the permission of the Chair

- 15.5.1 It is to inform the committee that we have filed an application with Government of India for sanction of Community Radio Station (CRS) at AITS Rajampet Campus. It requires at least Rs.15,00,000/- for installation of station equipment and for infrastructure.
- 15.5.2 In response to the Heads of the Departments request, it is brought to the notice of Finance committee that the certain training is essential on skill related courses to the students who are admitted in the year 2020-21 as per curriculum prescribed. The amount required for conducting such training is about Rs.6,40,000/-.
- 15.5.3 Other than the budget allocations and miscellaneous items, extra fund is needed for insurance requirements.
