

1. Change of course name from Executive Development Programme to Personality Development Programme.
2. Introduce Business and Legal Environment in I Semester.
3. Introduce Business Ethics and Corporate Governance as a course in I Semester and increase Corporate Governance content.
4. Conduct Personality Development Programme using a module or Manual and exercises.
5. Include advanced Office tools in Computer Applications Lab.(Advanced Excel)
6. Include topics in basket exercises, mind management, stress management and emotional management in PDP – II.
7. Introduce Cost and Management Accounting as a Core course in III Semester.
8. Introduce Supply Chain Management as a Core course in III Semester.
9. Add "Start up" of Business content in Entrepreneurship Development.
10. Introduce Industrial Relations and Labour Laws in III Semester and also introduce Knowledge Management in the same semester as HR Electives.
11. Introduce Corporate Finance as a Elective in III semester and include related to Taxation and Financial Reporting.
12. Introduce Entrepreneurial Stories as seminar topics.
13. Include topics Exporting Financing and modes of International Market Entry in curriculum.
14. Strategic Management and International Business Management brought from III semester to IV Semester.
15. Evaluate Project for 200 marks, carrying Internal marks 80 and external marks are 120.
